Output 1.1 Environmental Food Safety risk assessment measures implemented

1.1.1 Printing of food business licensing process manual and GHP/GMP Criteria

310 copies of BAFRA GHP/GMP Criteria for Licensing of Food Business and 310 copies of Food Business Licensing Process were printed and documents were distributed all BAFRA field offices. The documents were revised as per the recommendations of workshop and printed to be distributed to all BAFRA field offices and BAFRA officials as guidelines for licensing of food business. The documents also outline the process for feasibility inspection and Waste management system in the food industries which contributes to conservation of environment.

1.1.2-1.1.4 5 days workshop for 70 BAFRA officials on implementation of environmental food safety risk assessment for licensing of food business

The BAFRA field officials were oriented on Environmental Food Safety Risk Assessment for Licensing of food business in two batches. The workshop for western and southern region was organized in Thimphu from 5-9 September 2017 and second workshop was held from 8-12 January 2018 in Punakha for central and eastern region. 35 BAFRA officials including Officer In-Charges, Base In-charges and food inspectors from BAFRA field offices and focal officers from BAFRA, head office attended the workshop. The food safety measures such as the inspection of food establishment site to identify and prevent possible food safety hazards from the environment will help in addressing environmental contaminants of public health concerns. BAFRA has developed the GHP/GMP Criteria for Licensing of Food Business. However, BAFRA officials have not been adequately trained to implement the licensing process and field officials have come across various implementation issues. The workshop discussed such implementation issues and outlined the way forward for the effective implementation of Food Business Licensing Process.



Output 1.2: Biosecurity threats to environment prevented

1.2.1 Fixing traps/iron grid screens at the outlets of sewerage tanks at Phuentsholing to prevent the escape catfish species to the environment

The traps were fixed at the outlets of each sewerage tank to prevent escape of catfish. These fishes are invasive and eat other fishes. The traps will prevent escape of catfish from the sewerage into the natural water bodies.

The video clip to create awareness on impacts Tshethar cat fish in sewerage tank in Phuentsholing which was developed by BAFRA with fund support of BTFEC was presented to participants. The video clip embarks on the introduction of cat fish through Tshethar practices and as a significant biosecurity pest. The video also highlights the impact of cat fish to the native aquatic animals due to its invasiveness nature, carnivorous habitat. The clip proceeded with appropriate back ground commentary by program coordinator, Dr. Kinley. The 2.5 minute long clip precisely captured clause

38 of Livestock Rules &Regulation of Bhutan 2017, which exclusively prohibits the import of animal for the purpose of Tshethar. The coordinator then informed that though board directed to consult all the LG leaders, BAFRA prioritized Thimphu and Paro for the reason; its proximity in accessibility and high mode of Tshethar in practice. He said that they couldn't prolong the program either because of the ministerial instructions, not to delay the finalization.


The program then proceeded into presentation session; Advocacy over the legislation in existence and conformity to it. Through the presentation, Dr. Kinley informed the floor on how incidences of animal disease outbreak are being tackled by BAFRA & DoL involving the other relevant stakeholders. Responsibility and accountability of the LG leaders in this regard was highlighted.

1.2.3 Construct biological pits at Paro, Phuentsholing and Pemagatshel

The two biological pits for disposal of seized food items were constructed at Paro and Phuentsholing. The additional one biological pit was constructed in Pemagatshel with balance fund. The biological pits are designed in such a way that they facilitate the self decomposition of biodegradable items.

1.4.2 Two days awareness workshop on Import and Export Control Guideline for 25 Plant Inspectors (18 additional participants)

A two day workshop on "Strengthening Plant Biosecurity through import of clean and healthy Plants and Plant Products" for BAFRA Plant Regulatory and Quarantine Officials which is being organized by Bhutan Agriculture & Food Regulatory Authority (BAFRA), Ministry of Agriculture & Forests began today. Director General of BAFRA graced the opening session of the workshop which will be conducted for two days from 12-13 October 2016.

About 44 Plant Regulatory & Quarantine Officials are participating in the Workshop from all the field offices and entry points with facilitation from the BAFRA Management at the Head office, and experts from NPPC, DoFPS and NBC. The BAFRA Inspectors will be trained on Regulatory Framework for Import and Export of plants and plant products encompassing quarantine pest and diseases and Invasive Alien Species. This training will help in building the competencies of Quarantine Inspectors to identify the correct signs and symptoms of pest and diseases and take appropriate phytosanitary measures. Furthermore, the incidence of unlawful trade of endangered species of plants and plants products will be minimized through proficient inspection and certification process. It is crucial that Plant Inspectors are trained periodically and kept abreast with the latest information and know-how to prevent and combat biosecurity risk in appropriate time. The workshop is organized with a full financial support from the Bhutan Trust Fund for Environmental Conservation (BTFEC).

1.4.3 Printing of the guidelines for distribution to all relevant offices and participants

189 copies of Regulatory Framework for Import and Export of plants and plant products were printed and distributed to all Plant Inspectors, relevant agencies and BAFRA field offices for ready reference.

Output 1.5 Improved awareness for enforcing regulatory control of GMOs Background

With budget support from BFTEC Project, awareness programme was successfully conducted in all 20 Dzongkhags as 'One Day Mass Awareness Workshop' starting from 17th May 2017 onwards.

The Awareness programme was aligned with the objective of the Project, wherein the key messages were focused primarily on creating improved awareness for enforcing regulatory control of GMOs in line with the regulatory and safety management requirements as per the recently enacted Biosafety Act of Bhutan 2015.



Also, key messages were conveyed on biosecurity focused on preserving Bhutan's rich biological diversity and protecting food and farming system from exotic pests/diseases/invasive alien species and GMOs.

It was targeted to create awareness tokey stakeholders of BAFRA like Local Leaders, Farmers, Cooperative Groups, Nursery Growers, Importers, Exporters, Wholesale Retailers, Extension Agents, Hoteliers and Food Business Operators. The Awareness programme was conducted in densely populated Gewogs as well as far flung Gewogs of Bhutan to ensure that all the key players are well informed understand their role in conservation and protection of Bhutan's pristine environment from exotic pests/diseases/invasive alien species and GMOs.

Coordination of Awareness Programme

To strengthen national biosecurity and food safety, a total of Nu. 1.85 Million was released from BTFEC Project, in which Nu. 1.70 Million was for creating awareness workshop in 20 Dzongkhags and an amount of Nu. 0.15 Million was for printing and publication of awareness materials on GMO regulations for 20 Dzongkhags and BAFRA offices.

The details of the participants, centrally located venues and budget estimates were sought from BAFRA Dzongkhag Offices. As per budget estimates and as per allocated budget ceiling for this activity, advances were sanctioned to BAFRA Dzongkhag Offices. At the Dzongkhag level, the programme was coordinated and conducted under the supervision and guidance of Officer Incharges of BAFRA Dzongkhag Offices. The Officer Incharges and the programme coordinator were responsible for the settlement of bills and submission of activity report to BAFRA head office.

For the Awareness Programme, standard presentations were prepared by the Focal Officers in BAFRA Head Office and it was circulated to identify resource persons in 20 BAFRA Dzongkhag offices. The agenda for the Workshop was also circulated from the BAFRA Head Office to ensure that the programme was conducted uniformly in all 20 Dzongkhags.

SUMMARY OF ACTIVITIES

- An amount of Nu. 1.75 Million was incurred to conduct one day mass awareness activity in 110 (One Hundred Ten) centralized Gewogs.
- A summary and the details of the budget expenses submitted by the Officer Incharges of 20 Dzongkhags is as presented in the Table 1.

- An amount of Nu. 0.15 Million has been utilized for printing awareness materials for information dissemination to reach greater number of general public.
- A total of 5621 (Five Thousand Six Hundred Twenty One) participants attended the awareness workshop from 176 (One Hundred Seventy Six) gewogs from 20 Dzongkhags of Bhutan (Presented in Table 2)
- Also, detailed report of activities carried out at Dzongkhag level (along with pictures) is attached as Annex I.








