Greetings from the Certification Services, Bhutan Food and Drug Authority.

We are writing to inform you about updates related to the Food Product, Bhutan GAP, and Organic Certification Schemes in line with the ISO/IEC 17065 certification system.

Following the NABCB assessment conducted on November 25-26, 2024, a non-conformity (NC BDFA/SOA/2024/NC 04) was identified. As a result, the following certification schemes have been revised:

- Food Product Certification Scheme (DOC. BFDA-CS-01)
- Organic Product Certification Scheme (DOC. BFDA-CS-02)
- BhutanGAP Product Certification Scheme (DOC. BFDA-CS-03)

These revisions include minor modifications across various clauses, particularly in Section 6.4 concerning non-conformities. The updated documents can be accessed at the following links in BFDA Website:
